- Reduce our impact on the environment and communities in which we operate through pollution prevention, waste and emission minimization and reduction of natural resource consumption applying best practices;
- Investigate all incidents thoroughly in order to identify root causes and implement effective corrective & preventive actions;
- Provide a governance framework for HSE activities, including compliance with legal aspects of Turkmenistan;
- Provide necessary resources for training, information and consultation of employees to maintain good level of awareness and skills for best HSE performance;
- Be capable for responding to emergencies and recover from any HSE emergencies or crisis situations;

Monitor, keep record of our HSE performance against Key Performance Indicators
(KPI) to ensure continuous improvement.

PERSONAL PROTECTIVE EQUIPMENT (PPE) POLICY

In line with our Health, Safety and Environmental Protection Policy, «Rysgally Ussat» requires that all personnel working in or visiting our operational sites shall comply with the following requirements regarding the use of PPE:

- Minimum PPE, which are the steel-toed safety shoes / boots, safety glasses and safety helmets shall be worn at all times while at worksites unless within the approved safe areas ("green zone") such as an accommodation area;
- Safety coverall, safety glasses, safety foot-wear and gloves shall be worn in addition to the minimum PPE while performing any task at worksites;
- Additional specific PPE such as chemical protection suits, face shields, respirators, hearing protection and long sleeve rubber gloves shall be worn when directly involved in the chemical mixing process; Those who are not directly engaged in chemical mixing shall also consider wearing sufficient PPE before entering the risk zones considering potential chemical splashes, vapors etc.;
- Gloves and finger rings are prohibited during operation of high speed rotating machineries;
- Work permits and work instructions issued shall clearly identify all hazards and the PPE requirements;
- PPE shall be subject to regular inspections and replaced as needed where fail to provide adequate protection.

PPE mandatory areas shall be specifically signposted. PPE shall be approved for use by line management, who shall be responsible for implementing compliance with this Policy at our worksites.

SUBSTANCE ABUSE POLICY

In line with our Health, Safety and Environmental Protection Policy, it is our policy to prohibit any person working for, or with «Rysgally Ussat» and related entities to consume, to be in possession of or under the influence of drugs or alcohol while working at any location for «Rysgally Ussat».

Exceptions to this policy are for the use of approved medicines, prescribed by a certified doctor for a particular person's treatment. In this case, evidence in the form of a doctor's prescription for such medicine must be provided.

Violations to this policy will be subject to disciplinary action, up to termination of employment, and referred to the appropriate law enforcement officers.

SMOKING POLICY

It is policy of «Rysgally Ussat» to prevent any fire accidents caused by smoking, to mitigate the impact of smoking to the health of non-smokers and to comply with objectives of Turkmenistan in this regards.

Smoking is therefore prohibited in the following areas:

- High hazard work areas such as chemical production plant and storage facility;
- All offices or meeting rooms;
- All washrooms and lavatories;
- Pantry rooms;
- Storage facilities;
- Prayer rooms;
- Any other worksite location not designated as a smoking area.

Violations to this policy shall be subject to disciplinary action where repeated violations are made at non-designated areas.

STOP WORK POLICY

"Rysgally Ussat" is strongly and consistently committed to consolidating a culture of safe operation, as well as respect for people in all countries by raising awareness of the risks, related to the work and fostering responsible behavior.

By putting Health and Safety first, «Rysgally Ussat» means that no work can be done by jeopardizing safety. Any work must be 100% safe, even if it takes longer. Every employee of «Rysgally Ussat» is responsible for his/her own safety and for the safety of his/her colleagues and, regardless of his/her position, seniority or role, has the right and duty to demand to stop (the interruption) of any activity which he/she believes is putting health and safety seriously at risk.

Any unsafe behavior, action, omission or situation, which could lead to a potential incident, should be immediately reported to the immediate supervisor or to the responsible representative of «Rysgally Ussat» on the spot, in order to take prompt action. «Rysgally Ussat» management supports the decisions of its employees and contractors, and upholds health and safety against all other considerations.

The Stop Work policy must be applied reasonably and in good faith. No blame or fault will be put on any employee or contractor reporting a risky situation or applying the stop work policy, even if such an action is proven not necessary afterwards.

ANTICORRUPTION POLICY

We will provide training on this policy as part of the induction process for all new employees. We will also make every effort to guarantee that no one suffers any detrimental treatment as a result of refusing to accept or offer a bribe or other corrupt activities or because they reported a concern relating to potential act(s) of bribery or corruption.

Violations to this policy will be subject to disciplinary action, up to termination of employment, and referred to the appropriate law enforcement officers.

- To monitor and audit regularly the road safety performance and compliance;
- To report any accidents to local law enforcement authorities and to the organization's management in accordance with established procedures.

Failure to adhere to this policy may result in disciplinary action.
